

# 2014 Florida State Championship

## July 12 & 13

The 2014 Florida State Championship will be held at Okeehetee Park hosted by the Ski Club of the Palm Beaches. Practice will be available on Friday July 11, 2014 with the tournament running on Saturday July 12<sup>th</sup> and Sunday July 13<sup>th</sup>. There have been requests for the ability to ski more than one round at the State Championships from many competitors. In an effort to provide more rounds of record skiing at this event we have expanded, allowing you to ski 3 full rounds if you choose. Your Florida State Championship scores will **only** come from the first round.

To enter this event please complete the attached entry form and release(s). The format of the event does not lend itself to the On-Line Registration system. Please see the attached entry for and releases for submission.

This tournament is a 3 Event Record tournament with Florida State Championship scores coming from the first round only. There is a 15% discount for all junior skiers (Boys/Girls 1, 2 and 3) for the first round of skiing.

Start time for the tournament is 7:30am Saturday and Sunday.

Only paid entries secure a spot in the event. Full refund is available prior to tournament deadline of 7/3 with a 50% refund with notification prior to Wednesday of the tournament week. This tournament is open to out of state and out of country skiers. Only Florida residents are able to obtain medals in the first round which is the Florida State Championships.
